

## HELPFUL TIPS for the Tax Season

**Contribute to retirement accounts.** If you haven't already funded your retirement account for 2018, do so by April 15, 2019. That's the deadline for contributions to a traditional IRA, deductible or not, and to a Roth IRA.

**Collect records for tax time.** Watch the mail for IRS Forms 1099 and 1098 coming from Aeroquip Credit Union. Tax information is also included in your last statement of the year.

**File and pay on time.** The tax filing deadline is **April 15, 2019**.

**File electronically.** Because the IRS processes electronic returns faster than paper ones, you can expect an e-return three to six weeks sooner than refunds issued by mail.

**Choose direct deposit.** You can choose to have your refund split between multiple accounts, making it easy to automate your savings. Simply provide your credit union account number(s) and our routing number: **272481512**.
